

## HART DISTRICT COUNCIL

### (PROHIBITION AND RESTRICTION OF WAITING LOADING AND PARKING PLACES) (CONSOLIDATION)

#### ORDER 2017 (AMMENDMENT NO. 7) ORDER 2022

The Hart District Council pursuant to arrangements made under Section 101 of the Local Government Act 1972 with Hampshire County Council in exercise of its powers under sections 1, 2, 4, 32, 35, 45, 46, 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

The Hart District Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Consolidation) Order 2017 shall be amended by the revocation of the Map Schedules specified in the First Schedule to this Order and the insertion of the Map Schedules specified in the Second Schedule to this order.

1. The effect of this order will be

a) **No stopping at any time, on the following lengths of road:-**

***Alder Court, Fleet:***

[a] West side – from its junction with Willowbourne for a distance of 26.5 metres north to the access to the parking area. And then from the north corner of the parking area access for a distance of 6.5 metres to the southern boundary on property No. 1

[b] East side – from its junction with Willowbourne for a distance of 21 metres north to the parking area access. And then from the north corner of the parking area access for a distance of 12 metres north to the drain cover.

***Willowbourne, Fleet:***

[a] Northeast side – from the southeast corner of the build out in front of property No. 30 for a distance of 50 metres in a south-easterly direction.

[b] Southwest side – from the point in line with the northern boundary of property No. 23 for a distance of 26.5 metres in a south-easterly direction.

[c] North side – from its junction with Hitches Lane for a distance of 66 metres west to its junction with Alder Court. And then from the western corner of its junction with Alder Court for a distance of 11.5 metres west to the drain cover.

[d] South side – from its junction with Hitches Lane for a distance of 88 metres west to the drain cover.

***B3272 Hawley Road, Blackwater:***

[a] Northeast side – from lamp column number 44 for a distance of 78 metres northwest to its junction with Medlar Drive. And then from the northwest corner of its junction with Medlar Drive for a distance of 56 metres in a north-westerly direction.

[b] Southwest side – from a point opposite lamp column number 44 for a distance of 181 metres in a north-westerly direction.

***Medlar Drive, Blackwater:***

Northwest side – from its junction with B3272 Hawley Road for a distance of 26.5 metres in a north easterly direction to the dropped curb

Southeast side – from its junction with B3272 Hawley Road for a distance of 19.5 metres in a north easterly direction to the dropped curb.

***Rosemary Lane, Blackwater:*** Northwest side – from the boundary of property Nos. 7 and 8 for a distance of 37 metres in a south westerly direction.

***Sandy Lane, Church Crookham:***

[a] South side – from a point 10.5 metres north of lamp column No. 5C for a distance of 88 metres west to its junction with Manor Court, and then from the west corner its junction with Manor Court for a distance of 83 metres to its junction with Aldershot Road.

[b] South side – from the point 28 metres west of lamp column No. 9 for a distance of 120.5 metres in an easterly direction.

[c] North side – from lamp column No. 5A for a distance of 32 metres in a westerly direction, and from a point 6 metres east of lamp column No. 1 for a distance of 32 metres in a north-westerly direction to its junction with Aldershot Road.

[d] Both sides – from the point in line with lamp column No. 6 for a distance of 23.5 metres west to its roundabout with Jubilee Drive and Hampton close.

***Ryelaw Road, Church Crookham:***

[a] Both sides for a distance of 28 metres from its junction with B3013 Reading Road South

***A30 London Road, Hook:***

[a] Southeast side – in line with a point 12 metres northeast of lamp column No. 18 for a distance of 100 metres in a south-westerly direction.

[b] Northwest side – from the point 4 metres east of lamp column No. 14 for a distance of 33.5 metres northeast to its junction with Sheldon's Lane, and then from the northeast corner of its junction with Sheldon's Lane for a distance of 37 metres in a north easterly direction.

**King Street, Odiham:** West side – from the southern boundary of Prospect Cottage for a distance of 4 metres in a southerly direction.

***Palace Gate, Odiham:***

[a] East side – from the point 9.5 metres north of lamp column No. 3 for a distance of 25.5 metres in a northerly direction.

[b] East side – from a point 2 metres north of lamp column No. 6 for a distance of 77 metres along its kerb edge in a northerly direction.

***Chatter Alley, Dogmersfield:*** Both sides – from the point in line with the north west corner of its junction with Church Lane for a distance of 35.5 metres in a north westerly direction.

***Church Lane, Dogmersfield:***

[a] Northwest side – from its junction with Chatter Alley for a distance of 25 metres in a south westerly direction, and then from the boundary between Field View and Kersfield house for a distance of 34.5 metres in a south westerly direction, and then from a point opposite the south west corner of its junction with Pilcot Road for a distance of 10 metres in a south westerly direction.

[b] Southeast side – from its junction with Chatter Alley for a distance of 20.5 metres in a south westerly direction, then from a point opposite the boundary between Field View and Kersfield house for a distance of 11.5 metres southwest to its junction with Pilcot Road, then for a distance of 6.5 metres across the island within the junction of Pilcot Road, then from the southwest corner of its junction with Pilcot Road for a distance of 10 metres in a south westerly direction.

***Dilly Lane, Hartley Wintney:*** South side from the point 5 metres east of lamp column No. 4 for a distance of 20 metres in a westerly direction.

***Green Lane, Hartley Wintney:*** Both sides – from the point in line with lamp column No. 13 for a distance of 22 metres south west towards Mitchell Avenue.

- b) **No waiting Monday to Friday 8:15 to 9am and 2:30 to 3:30pm excluding bank holidays on the following lengths of road:**

***Sandy Lane, Church Crookham:***

[a] North side – from a point 6 metres east of lamp column no. 1 for a distance of 108.5 metres in an easterly direction.

[b] North side – from a point opposite lamp column No. 9 for a distance of 92.5 metres in an easterly direction.

- c) **No waiting Monday to Friday 8am to 6pm on the following lengths of road:**

***Southby Road, Fleet:***

[a] Southwest side starting in line with a point 3 metres northwest of lamp column No. 1 for a distance of 26.5 metres in a south easterly direction.

[b] Northeast side from a point 3 metres northwest of lamp column No. 1 for a distance of 36.3 metres in a south easterly direction.

- d) **No waiting by goods vehicles over a maximum weight of 5 tonnes Monday to Friday midnight to 7 am and 8 pm to midnight Saturday and Sunday at any time on the following lengths of road:**

***Bartley Way, Hook:*** Both sides from its junctions with B3349 Griffin Way South as it runs around the north and west sides of Providence House for a distance of 392 metres.

- e) **Revoke the No waiting Monday to Friday 1pm to 2pm and replace with No waiting at any time on the following lengths of road:**

***Darset Avenue, Fleet:*** Both sides – from a point 4 metres west of lamp column No. 1 for a distance of 17 metres in an easterly direction.

- f) **Revoke the No waiting Monday to Friday 10am to 11.30am on the following lengths of road:**

***Tavistock Road (Spur) for properties Nos. 1 to 9, Fleet:*** Around all sides from the point 15 from the centre line of its junction with Tavistock Road (Part) (Spine).

- g) **Revoke the parking Monday to Friday 8am to 6pm 1 hour No return within 1 hour Except Permit Holders and replace with Permit Holders Only on the following length of road:**

***Albert Street, Fleet:*** South-east side – from a point 3 metres south-west of lamp column No. 16 for a distance of 46 metres in a south-westerly direction.

- h) **No stopping at any time except local busses on the following length of road:**

***B3013 Beacon Hill Road, Church Crookham:*** East side from the point one metre north of Lamp column No. 5 for a distance of 36 metres south to the end of the taper.

***Sandy Lane, Church Crookham:*** North side from the point in line with lamp column No. 9 for a distance of 18 metres in a westerly direction.

- i) **Disabled badge holders only on the following lengths of road:**

***Blaire Park, Yateley:*** In the northeast corner of the parking area adjacent to properties Nos. 72, 70 and 62 for a distance of 6 metres in a westerly direction.

***Adjacent to Bramshot Farm Country Park, Bramshot Lane, Fleet:*** East side for a distance of 10 metres in a northern direction from a point 90 metres from the centre of its junction with A3013.

2. This order shall come into operation on xx December 2022 and may be cited as the Hart District Council (Prohibition and Restriction of Waiting and Loading And Parking Places) (Consolidation) Order 2017 (Amendment No. 7) Order 2022.
